Bullying 101

-Bullying is defined as making fun of, putting down, or threatening

(physically, verbally or both) another person.

-Bullying is done on purpose and is often repeated.

So why is this happening?

Warning Signs of Bully or Victim:

- -Quickly switches screens or closes programs when someone walks by
- -Uses the computer or phone till all hours of the night
- -Gets unusually upset if she/he cannot use the computer or phone or after using the computer
- -Laughs excessively while using the computer
- -Appears nervous or jumpy when an IM message appears.
- -Avoids discussions about what they are doing on the computer
- -Becomes withdrawn from friends and family

Effects of Bullying

- -The Victim
- -The Bully

What Teachers or Counselors can do if student reports being bullied or cyberbullied:

- -Ensure the safety of the student (victim).
- -Investigate and gather information.
- -Contact the child's parents.
- -Contact the Internet Service Provider.
- -Contact the police if physical threats are involved.
- -Enforce disciplinary policy.

What NVUSD is Doing:

-BEST is mandatory at all school sites

-BE SAFE, BE RESPECTFUL, BE RESPONSIBLE

- -Positively stated behavioral expectations taught and reinforced 15 20 times per year
- -Positive Reinforcement System (e.g. "Blue Eagle" Tickets) when students demonstrate desired behaviors
- -Consistent correction when problem behaviors occur (reteaching, parent contact, restorative practices)

What NVUSD is Doing:

Research based Social Emotional Curriculum mandatory grades K-8:

- -Second Step
- -Steps to Respect
- -Life Skills Training
- -Empathy
- -Problem Solving Skills
- -Anger Management
- -Bullying

NVUSD New Board Policy

- -Positive School Climate Board Policy
- -Innovative, one of only two in the state (LAUSD)
- -Describe responsibilities of students, teachers, parents, administrators
- -Consequences for misconduct explicitly described
- -Use of more supportive interventions aimed at teaching new behaviors, not just sanctioning students
- -BEST and Social-Emotional Learning Implementation, 2008-2011
- -BEST Implementation Impact on NVUSD Suspensions & Expulsions

Tips for Parents/Concerned Friends

- -Keep computers in easily viewable places. (E.g. family room, kitchen...never the bedroom.)
- -Keep the lines of communication open, recognizing that the internet and cell phones are here to stay.
- -Learn about and use the new technologies.
- -Talk about guarding passwords!
- -Talk to kids about social networking sites and how to stay safe, (example: go over Facebook rules together)
